



General Information, Requirements and Regulations for the Individual Workshop with Nic Dunlop in Bangkok

Please read carefully. By applying to the workshop you agree to all information, requirements and regulations included in this document.

1 Details

2 Application

If you don't have a website, please attach a zip file with 12-20 photographs and a personal statement.

3 Payment

Full payment should be made within 7 days from receiving the request for payment to confirm the place. If payment is not received on time, the application will be canceled. In case you're booking the workshop more than three months prior to its date, you may be asked to pay 10% of the tuition fee in advance first.

4 Cancellations and refunds

Should you withdraw from participation in the workshop up to a month before it takes place, half of the tuition fee will be refunded. After this limit,

no refund can be made.

The organizer may cancel the workshop in case of serious constraints. In such an unlikely event, a full refund of the paid fee will be made.

5 Requirements

The workshop is designed for photographers with understanding of the photographic process. You should arrive with working knowledge of your equipment and ready to shoot. The workshop is limited to digital cameras, however during the photo editing sessions you will use small prints (you will be asked to print your daily shoot's selection in a lab).

The workshop will be conducted in English. Participants agree that photographs taken by them during the workshop may be used in workshopx on-line publications and promotional materials.

6 Travel, personal safety & accommodation

Participants make their own arrangements regarding travel, insurance and accommodation and ensure that they have all the necessary travel documents and relevant visas in order to attend the event. Please check carefully the Thai visa application process details for your country/nationality to avoid unnecessary refusals. Please apply for tourist visa. The organizer of the workshop doesn't take responsibility for problems with visas and no tuition refund will be made for that reason.

Participants also take full responsibility for their personal security during their journey to and stay in Thailand.

1. Each participant covers the entire cost of participation in the Workshop and takes full responsibility for their actions. Especially, each participant is responsible for arranging personal and travel insurance for the duration of their stay in Thailand.
